

## **RELEASE OF LIABILITY, WAIVER OF ALL POSSIBLE CLAIMS AND ASSUMPTION OF RISK**

*This Release of Liability, Waiver of All Possible Claims and Assumption of Risk (herein "Waiver") is being executed for the protection of participants, agents, employees and contractors of ANOZIRA KRAV MAGA LLC, (herein collectively referred to as "ANOZIRA"). By signing this Waiver you are agreeing not to sue ANOZIRA or any of their employees, participants, members, agents or contractors, for any loss or damage you may suffer, whether personal injury, death or property damage, as a result of participating in any activity organized by ANOZIRA or its members.*

### **Release and Waiver of Liability**

In consideration of being accepted as a participant of activities or classes sponsored by or on behalf of ANOZIRA and being permitted to participate in activities organized or sponsored by ANOZIRA, I have been fully informed of the nature of the activities and the physical dangers therein and I acknowledge and agree as follows:

- I agree to relieve ANOZIRA of all liability for all loss or damage arising out of any cause whatsoever and hereby exempt ANOZIRA from the legal consequences that would otherwise flow from such causes. I hereby release, waive and discharge ANOZIRA from all liability to myself, my heirs, executors, administrators and assigns for all loss or damage and any claims or demands for such loss or damage on account of injury to my person or property or by my death from any caused whatsoever I further agree not to sue ANOZIRA.
- I am the full age of 18 years. If I am not the full age of 18 years, my parent or guardian has fully read and understands this Waiver. I understand my parent or guardian must also sign below prior to my participation in any Activities. I am aware of the nature and effect of this Waiver.
